CNA ComPass[™] provides agents and brokers with access to their International policies on CNA Central. For assistance, use these access instructions (with screenshots) or follow these steps:

- 1. Log into CNA Central at cnacentral.com.
- **2.** In the left navigation bar, click "Service My Accounts" and then "Electronic Document Delivery."
- In the Electronic Document Delivery section, complete the fields for "Branch Code" and "Producer Code."
 Note: Refer to the specific Premium Invoice you received for the WorldPass[®] policy for the two codes. Located at the top right of the invoice, these appear as numbers ending with 884.
- **4.** The next screen will populate all policies that have been uploaded under the unique Branch/Producer code selected.
 - This screen enables filtering capabilities, allowing you to search based on Policy Number, Customer Name and Effective As Of. (When searching by Policy Number, do not include the WP or PST prefixes, just the number.)
 - Available documents will appear on this screen with a "View Document" link to the right. Agents/brokers without CNA Central access: Contact your CNA FSS Representative to gain access. For additional assistance, please contact 1-800-262-4357 (1-800-CNA-HELP).
