Companies that offer software development, computer programming, data processing, consulting, internet-related services, system analysis and design, software consulting and training, and information retrieval including:

- Software developers, custom programmers, system integrators and providers of computer consulting and other computer related services
- Internet access and service providers
- Providers of web hosting and web design services
- Computer processing and data preparation services
- IT government contractors
- Companies that facilitate cloud computing and emerging technology infrastructure
- IT staffing other than permanent placement
- Data processing schools

Electronics Manufacturers

Companies that manufacture products used to process or display data, including component parts of those systems; companies that manufacture instruments that are controlled electronically including:

- Companies that develop, design and engineer electronic components including those that outsource manufacturing overseas (fabless)
- Manufacturers / Assemblers of computer chips, wiring, harnesses, cables, electronic connectors, circuit boards and other component parts
- Manufacturers / Assemblers of computers and peripheral equipment such as printers, computer storage devices, display devices, document entry, optical scanning, point of sale devices and office machines
- Manufacturers / Assemblers of telecommunications and broadcasting, and commercial audio, video equipment
- Electronic photographic equipment and parts manufacturers
- Manufacturers / Assemblers of instruments and related products for measuring, displaying, transmitting and use in research and development labs

Communications Companies

Telecommunications / cable companies who sell or resell local, long distance, paging, data services, internet bandwidth, cable television, internet, cable, cellular and land line services or equipment including:

- Providers (sellers and resellers) of local and long distance telephone service, paging, cellular, cable television service and fiber optic services
- Value added resellers of telecommunications equipment
- Video conferencing service providers
- Companies that consult on, design or recommend communication networks
- Wireless service companies
- Companies that offer bundled services such as cable, internet and phone

Media

Producers and creators of traditional and electronic content including:

- Creators of digital content
- Traditional and digital newspaper, periodical, book and miscellaneous publishers

Distribution relation to technology products

- Computer hardware and software stores
- Companies that distribute computers, computer peripherals, software and electronic parts

End use and end user are critical to determining eligibility. Risks with the following exposures require more careful underwriting and may not be eligible for all lines of business:

- Software that has a high consequential bodily injury or property damage liability exposure
- Electronic devices and components that control transportation, power grid or utilities
- Communication risks when the majority exposure is construction
- Controversial or adult content providers
- Distributors with significant warehouse or delivery fleet exposures
- Companies that derive the majority of their revenue from low tech outsourcing services such as call center where high turnover or part time employment exists
- Online gaming
